1. Describe the experience of the applicant and potential subrecipients (if any), in effectively utilizing federal funds and performing the activities proposed in the application, given funding and time limitations.

Shelter Care has been providing short and longer term housing to families utilizing a variety of federal and local funds for over 20 years. These include CoC grants, Emergency Solutions Grants, FEMA funding, as well as local and state funding. Shelter Care uses a combination of foundation grants, general fundraising dollars, and in kind donations and volunteer hours as match.

Shelter Care has extensive experience performing the activities proposed in the application including: providing leasing and rental assistance, operations including maintenance and furniture, and supportive services including case management, assistance with obtaining benefits, helping families increase income, and ensuring children and adults have access to education and resources to be successful.

2. Describe the experience of the applicant and potential subrecipients (if any) in leveraging other Federal, State, local, and private sector funds.

Shelter Care is proficient at fundraising and grant writing to secure match dollars for all current federal grants. In addition, Shelter Care has recently started tracking eligible donations and volunteer hours to be used as match.

3. Describe the basic organization and management structure of the applicant and subrecipients (if any). Include evidence of internal and external coordination and an adequate financial accounting system.

The organizational structure applicable to CoC grants includes the executive director who oversees all operations of the agency, including ensuring grant reporting and compliance. There is also a Finance Director who manages all financial aspects of the organization and completes financial portions of all grant reports. The Finance Director works closely with the person on staff who coordinates volunteers and donations to ensure proper documentation of items and hours for grant match. On the front lines are the housing advocates/case managers. Advocates deliver all the direct services to clients. Shelter Care uses an accrual accounting system in Quickbooks, as well as tracking donations and volunteer hours in donor perfect. Excel spreadsheets are used for tracking grant expenditures and submitted to the Collaborative applicant (City of Rockford) on a monthly basis for reimbursement. We have an external audit conducted each year as required by law.

1. Provide a description that addresses the entire scope of the proposed project.

Shelter Care will provide Rapid Rehousing rent and supportive services to homeless families in Winnebago and Boone Counties in IL. Families could receive rent assistance for up to two years, with a focus on helping each family gain financial stability within 12 months so they can pay their full rent. Families who are unable to increase cash income to a level necessary to afford market rent are referred to the local Public Housing Authorities to obtain subsidized housing. Families receive intensive case management, in general once per week, especially towards the beginning of their entry into the project. This can decrease to once per month once the family is financially stable and does not have intense service needs.

2. Shelter Care has historically paid for maintenance issues directly related to program participants. These could be accidental or intentional. In addition, Shelter Care has frequently paid for bed bug and roach treatments, especially in single unit housing where program participants most likely brought the pest issues with them to the unit. Finally, after a family exits PSH for other permanent housing, there are always costs related to cleaning and repairing the unit so a new PSH family can reside there.

7. Will participants be required to live in a particular structure, unit, or locality, at some point during the period of participation? Yes

Explain how and why the project will implement this requirement.

Shelter Care currently leases 12 units of housing for Permanent Supportive Housing. All of these have a current 12 month lease. If a family were to exit PSH before the lease had expired, Shelter Care would continue paying the rent and a new family referred through the Coordinated Intake and Assessment process would be placed in the vacant unit. The new family could elect to move to a unit of their own choosing when the current lease expires. This has happened many times, even when the family self-selected the first house or apartment.

Dedicated and DedicatedPLUS

When participants are referred from Coordinated Intake and Assessment (Single Point of Entry), a case manager provides guidance regarding selecting a rental property if applicable. If Shelter Care has a currently leased and vacant PSH unit, the family would move into the current leased unit. If the family does need to select their own unit, case managers provide transportation, a letter explaining the program, and field calls from prospective property owners. Case managers make themselves available to answer calls from landlords to explain the program in further detail if needed. Throughout the time a participant is involved in PSH with Shelter Care, case managers regularly speak with property owners and work to mitigate any potential problems before they become eviction-able offences, such as visitors who aren't on the lease, property upkeep issues, or noise complaints. In the rare case a participant is evicted, Shelter Care works to help them find alternative housing.

Each participant family will be assigned a case manager/housing advocate who will work one on one to improve job readiness and access to employment. Case managers help edit resumes, assist with interview and employment clothing, either transport or provide gas vouchers or bus tokens to get to and from work or interviews, refer participants to job training in the community, such as Workforce Connections and the Works Center, and help make child care arrangements to once participant is employed, she can remain employed. All

families are strongly encouraged to pursue both TANF and Child Support, especially if they enter the program with zero income.
