The Shelter Plus Care 1998, project serves homeless households whose head of household has been diagnosed with a serious mental illness or serious mental illness with co-occurring substance use disorder. The grant has been active since 1994 serving between 86-96 households in the past year. The focus is to place persons who have the most serious level of illness and need intense services to maintain their housing. Many of these individuals have poor rental histories and poor legal backgrounds due to their symptoms. We work closely with around 70 landlords to assist in securing housing quickly for these individuals. Dollars received in rental assistance are matched in mental health care by the sub-recipient.
